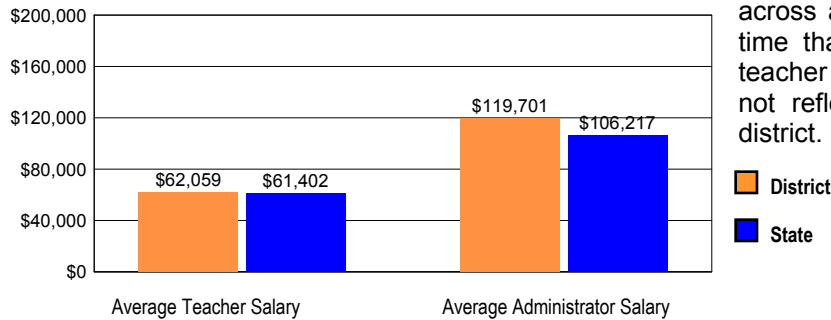

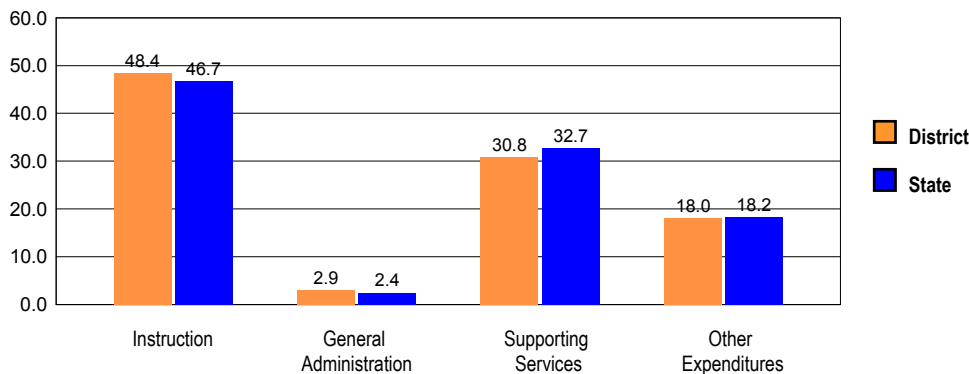
SCHOOL DISTRICT FINANCES

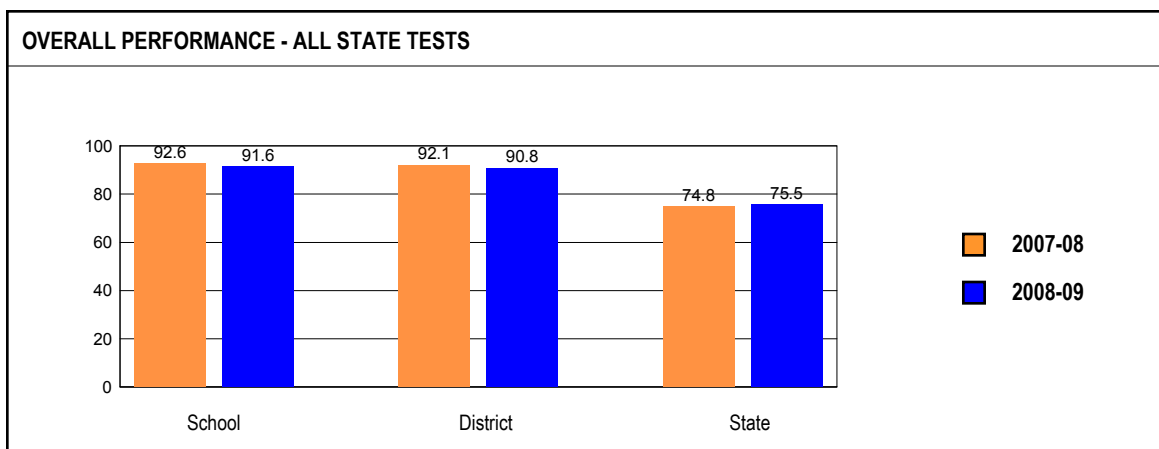

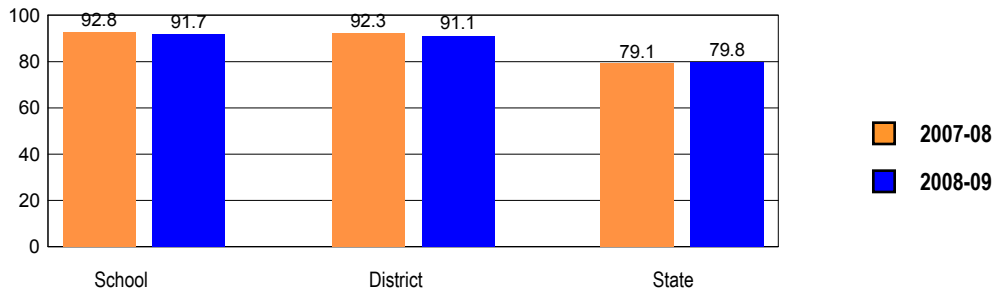
OVERALL STUDENT PERFORMANCE

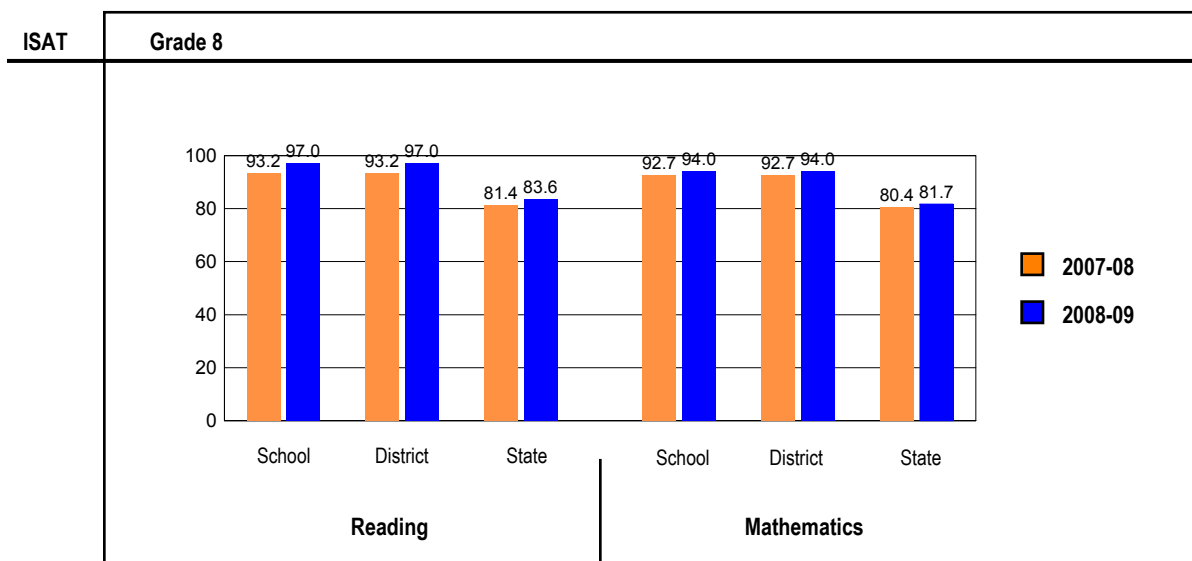
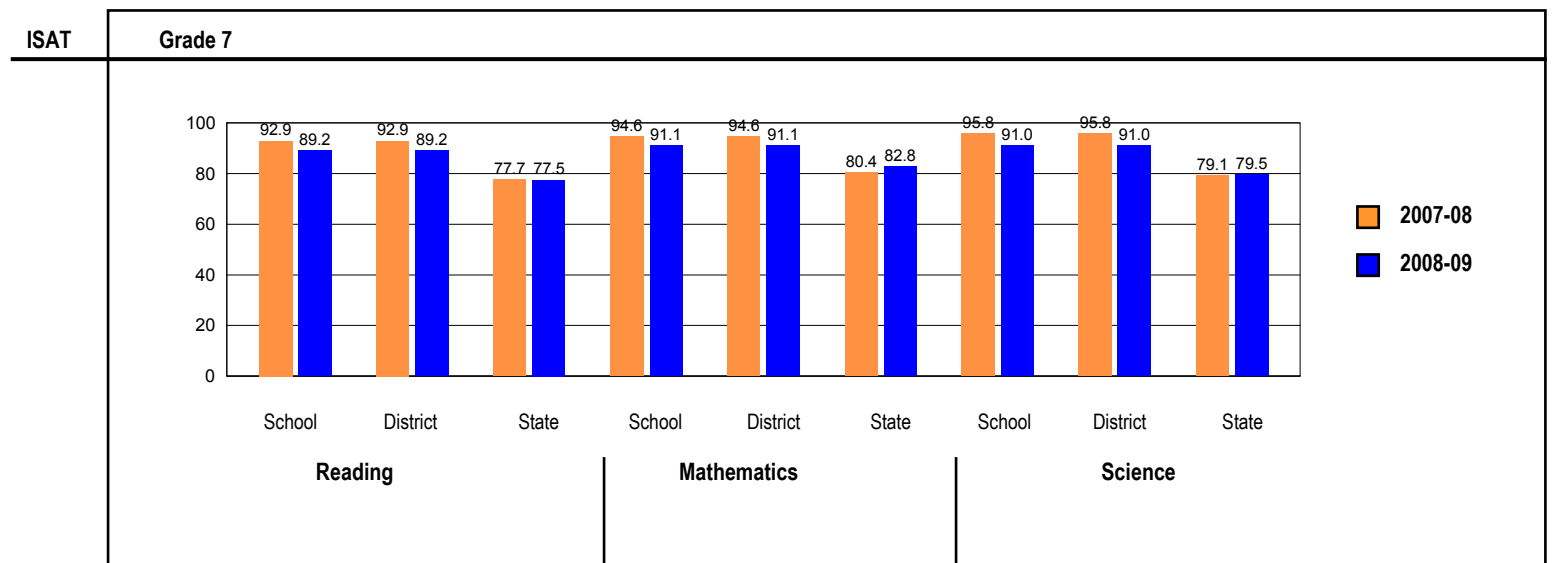
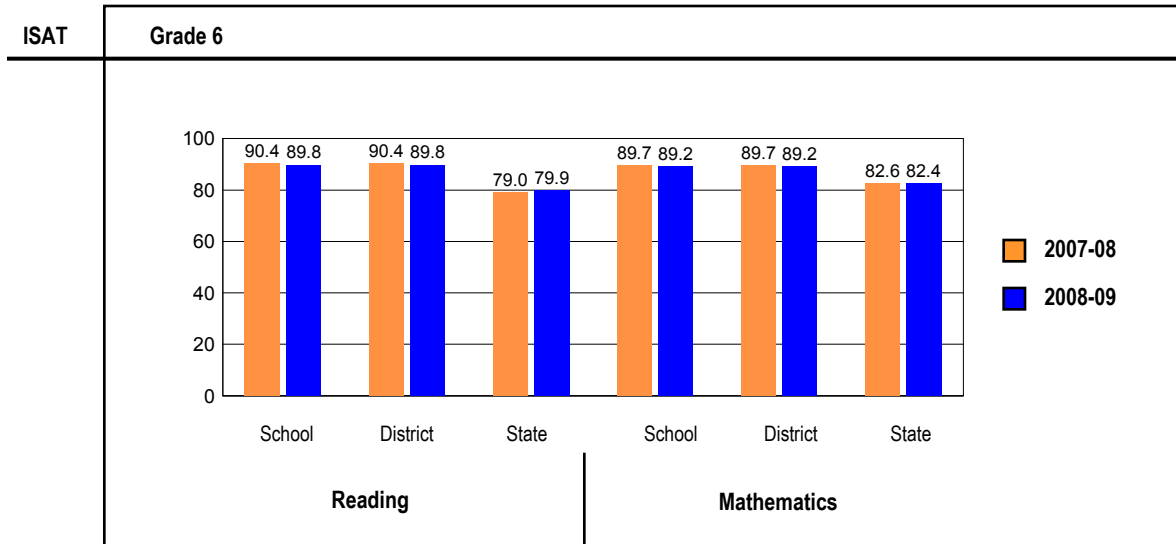


OVERALL ILLINOIS STANDARDS ACHIEVEMENT TEST (ISAT) PERFORMANCE

PERFORMANCE ON STATE ASSESSMENTS

Federal law requires that student achievement results for reading, mathematics, and science for schools providing Title I services be reported to the general public.

The Illinois Standards Achievement Test (ISAT) is administered to students in grades 3 through 8. The Prairie State Achievement Examination (PSAE) is administered to students in grade 11. The Illinois Alternate Assessment (IAA) is administered to students with disabilities whose Individualized Education Programs (IEPs) indicate that participation in the ISAT or PSAE would not be appropriate.

Students with disabilities have an IEP (No Child Left Behind Act). An IEP is a written plan for a child with a disability who is eligible to receive special education services under the Individuals with Disabilities Education Act.

Reading and Mathematics are tested in grades 3 through 8 and 11. Science is tested in grades 4, 7, and 11.

In order to protect students' identities, test data for groups of fewer than ten students are not reported.

ILLINOIS STANDARDS ACHIEVEMENT TEST (ISAT)

The following tables show the percentages of student scores in each of four performance levels. These levels were established with the help of Illinois educators who teach the grade levels and learning areas tested. Due to rounding, the sum of the percentages in the four performance levels may not always equal 100.

Level 1 -- Academic Warning - Student work demonstrates limited knowledge and skills in the subject. Because of major gaps in learning, students apply knowledge and skills ineffectively.

Level 2 -- Below Standards - Student work demonstrates basic knowledge and skills in the subject. However, because of gaps in learning, students apply knowledge and skills in limited ways.

Level 3 -- Meets Standards - Student work demonstrates proficient knowledge and skills in the subject. Students effectively apply knowledge and skills to solve problems.

Level 4 -- Exceeds Standards - Student work demonstrates advanced knowledge and skills in the subject. Students creatively apply knowledge and skills to solve problems and evaluate the results.

Four Conditions Are Required For Making Adequate Yearly Progress (AYP):

1. At least 95% tested in reading and mathematics for every student group. If the current year participation rate is less than 95%, this condition may be met if the average of the current and preceding year rates is at least 95%, or if the average of the current and two preceding years is at least 95%. Only actual participation rates are printed. If the participation rate printed is less than 95% and yet this school makes AYP, it means that the 95% condition was met by averaging.
2. At least 70.0% meeting/exceeding standards in reading and mathematics for every group. For any group with less than 70.0% meeting/exceeding standards, a 95% confidence interval was applied. Subgroups may meet this condition through Safe Harbor provisions. ***
3. For schools not making AYP solely because the IEP group fails to have 70.0% meeting/exceeding standards, 14% may be added to this variable in accordance with the federal 2% flexibility provision.
4. At least 90% attendance rate for non-high schools and at least 78% graduation rate for high schools.

For subgroups that do not meet their Safe Harbor Targets, a 75% confidence interval is applied. Safe Harbor allows schools an alternate method to meet subgroup minimum targets on achievement.

Westfield Middle School School Improvement 2009-10

Target Area for Improvement:

Our building goals for this 09-10 year include: (1) 90% of Westfield students will maintain ISAT scores at the “meets or exceeds” levels in Reading, Math and Science while ISAT writing scores will improve across all grade levels; and (2) promote a positive culture and climate by increasing positive student behaviors seeing ultimately a decrease in bullying harassment and disrespect overall in the students population.

Based upon the 2009 ISAT results and focusing on the goal (1), the School Improvement Team celebrated areas of strengths and have committed to maintaining these exceptional test scores that have “met or exceeded” the 90%. Staff continues to pursue writing as a skill we still need to improve and we will continue to expand our instructional strategies in content area writing across the curriculum.

Rationale:

The target goal (1) will be monitored through the School Improvement Process. SIP Team members will work with grade level teams to regularly discuss data to determine if we are making progress. The consistent collection of data, differentiation interventions, and data driven decision making over the last three years has had a dramatic impact on improving overall student achievement.

This fall, when the School Improvement Team reviewed the new ISAT 2009 data, scores exhibited higher ratings overall. Further, it was determined that expanding content area writing and our continued work with the state-level writing consultant has and will continue to increase our overall writing scores.

Current Interventions:

Teachers are using Measures of Academic Progress (*M.A.P.*) to identify gaps in order help Westfield reach our building goals and increase student achievement. With the goal to increase writing scores, teachers will design carefully structured writing activities to be implemented into classroom lessons to increase understanding and achievement. We continue to examine student data allowing us to track achievement data trends. Students not receiving special services will be identified based on the Response to Intervention (*RtI*) model. While *MAP* testing will continue to provide a diagnostic picture of where our students are in their academic learning, new progress monitoring tools will be introduced for diagnostic assessment.
