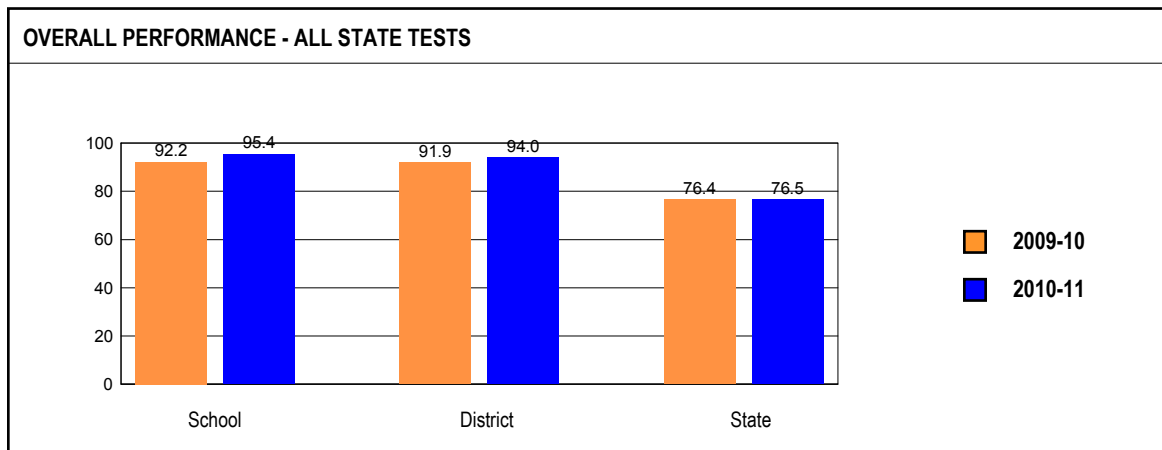

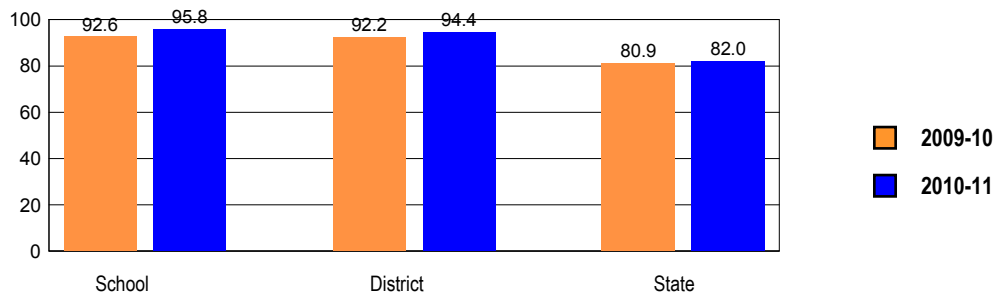

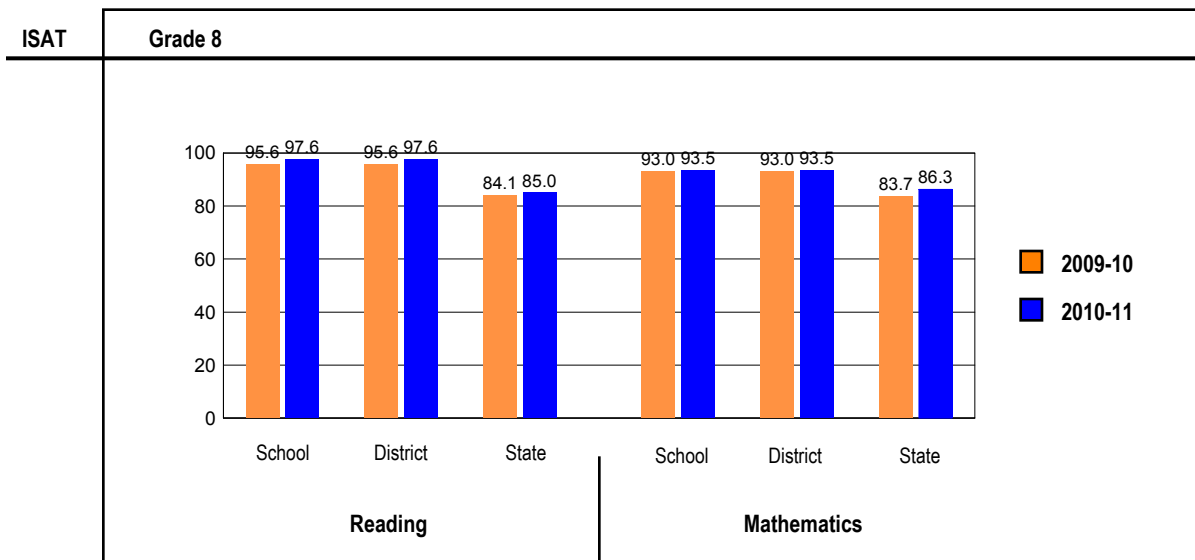
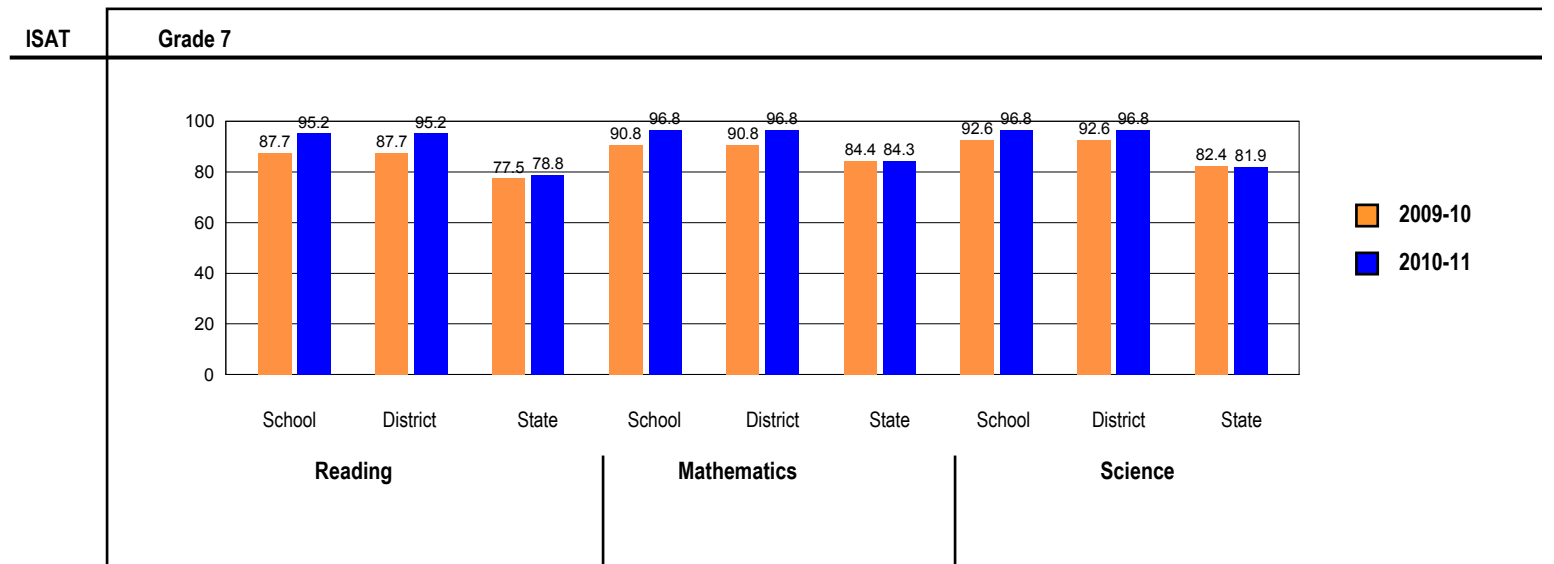
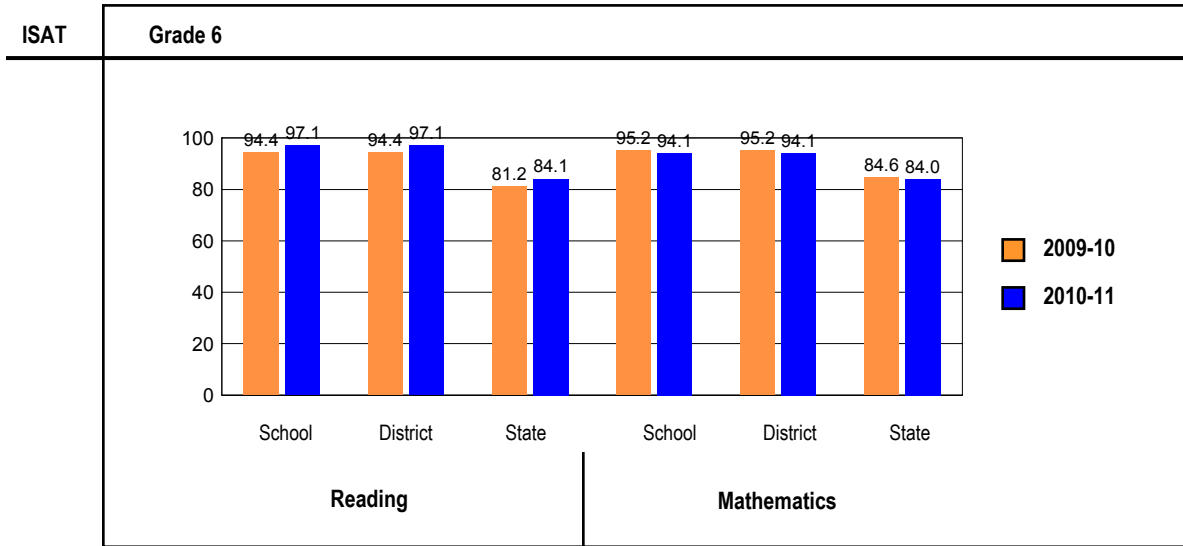


**OVERALL ILLINOIS STANDARDS ACHIEVEMENT TEST (ISAT) PERFORMANCE**

## PERFORMANCE ON STATE ASSESSMENTS

Federal law requires that student achievement results for reading, mathematics, and science for schools providing Title I services be reported to the general public.

The Illinois Standards Achievement Test (ISAT) is administered to students in grades 3 through 8. The Prairie State Achievement Examination (PSAE) is administered to students in grade 11. The Illinois Alternate Assessment (IAA) is administered to students with disabilities whose Individualized Education Programs (IEPs) indicate that participation in the ISAT or PSAE would not be appropriate.

Students with disabilities have an IEP (No Child Left Behind Act). An IEP is a written plan for a child with a disability who is eligible to receive special education services under the Individuals with Disabilities Education Act.

Reading and Mathematics are tested in grades 3 through 8 and 11. Science is tested in grades 4, 7, and 11.

In order to protect students' identities, test data for groups of fewer than ten students are not reported.

### ILLINOIS STANDARDS ACHIEVEMENT TEST (ISAT)

The following tables show the percentages of student scores in each of four performance levels. These levels were established with the help of Illinois educators who teach the grade levels and learning areas tested. Due to rounding, the sum of the percentages in the four performance levels may not always equal 100.

- Level 1 -- Academic Warning - Student work demonstrates limited knowledge and skills in the subject. Because of major gaps in learning, students apply knowledge and skills ineffectively.
- Level 2 -- Below Standards - Student work demonstrates basic knowledge and skills in the subject. However, because of gaps in learning, students apply knowledge and skills in limited ways.
- Level 3 -- Meets Standards - Student work demonstrates proficient knowledge and skills in the subject. Students effectively apply knowledge and skills to solve problems.
- Level 4 -- Exceeds Standards - Student work demonstrates advanced knowledge and skills in the subject. Students creatively apply knowledge and skills to solve problems and evaluate the results.

Westfield Middle School is once again setting their sights high in regards to our students and their achievement. The last 5 years we have seen outstanding gains in our student achievement that have inspired our staff, students and parents. We attribute all of our achievement to the allotment of team planning times and the components of our Professional Learning Communities.

Last year, we celebrated our best year yet with meeting our goal of 90% of our students in 6-8 Grade Meeting or Exceeding on both the Reading and Math ISAT test. We are encouraged by these results and will continue to support our struggling learners with a wide variety of interventions. These interventions include:

- ISAT Bubble Kid Group
- ISAT Lunch Bunch Group (Voluntary)
- Compass Learning (Math & Reading)
- Reading Plus
- Map Goal Setting & RIT Band work

New this year will be the Compass Learning Program. We are excited to offer this to students as it directly ties into their MAP Score and the areas in which they are struggling. It will also provide enriching instruction for our learners who are already exceeding expectations. We are confident that Compass Learning will offer yet another opportunity for our staff to meet the needs of all of our students.

The ECRA Group will also support us in our efforts to improve the students writing. Through a pre-assessment and post – assessment derived from the ECRA Group, Westfield ELA teachers will be given valuable data that will help them in their writing instruction.

In looking at our cognitive building goal for the year, Westfield celebrated the fact that we did meet our goal of well over 90% of our students meeting and exceeding on the ISAT Exam. Our goal for 2011-12 is, ***“by the end of school year, 70% of Westfield students will achieve their own growth target on NWEA Map Assessment in Math and Reading as shown on the AGS Report by NWEA.*”**

The Westfield staff is committed to using data to move forward in adapting curriculum to ensure improved student academic performance. M.A.P. and ISAT tests will continue to be pertinent to the overall school academic success with the focus to sustain annual test scores across all grade levels above the 90% in Reading, Math and Science, and to focus on helping students reach their growth target on the NWEA Map Assessment.
