Sept 28<sup>th</sup> thru April 26<sup>th</sup>

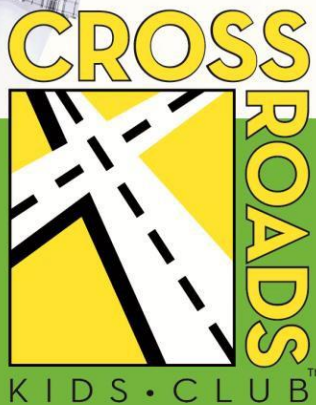
