WHAT'S NEEDED TO ENROLL MY STUDENT?

Access the Online Enrollment Form for Kindergarten and New Students

Go to [SD13.org](https://www.sd13.org) > District Information > New Student Enrollment

Follow these steps to get to this form via the School District 13 website:

- Using a current browser, go to <https://www.sd13.org>
- In the upper left corner, click District Information
- Click on New Student Enrollment in left menu
- Read the content to select the correct form
- Upload required documentation when completing the online form

Proof of Residency

Proof of Residency is required for all students. Three documents, one from each category and all having the same home address, must be provided as proof of residency.

Illinois Department of Motor Vehicle Offices (DMVs) have now reopened. Updated IDs must show current home address within SD13 boundaries.

- Category 1 – Personal Identification
 - Valid Illinois Driver's License
 - Valid Illinois State ID
 - Other Valid Photo ID with Address
- Category 2 – Home Identification
 - Current mortgage statement or closing statement from bank or lender
 - Real estate tax bill from current school year
 - Current lease showing the name, address and phone number of landlord
- Category 3 – Occupancy Verification
 - Current electric, water, gas or cable/internet bill that includes your name and address
 - Current Homeowners Insurance
 - Recent Illinois vehicle registration (dated within 6 months of form submission)
 - Pay stub from your employer (with current home address)
 - Current public aid card or document from DHS or DCFS that includes your name and address

NOTE: If documents from Category 2 and Category 3 cannot be provided, print and complete a [Notarized Affidavit of Residency Form found here](#). Affidavit forms may **not** be uploaded and therefore must be brought into the main office of your child's school. Along with the completed affidavit form and parent/guardian identification, three documents from the homeowner (one from each category and all having the same home address) must be brought into the main office of your child's school. Please call your child's school to schedule an appointment to bring in required Affidavit documents.

The Illinois School Code requires all children entering Kindergarten or transferring to a new school to have a physical exam and certain immunizations prior to entering school. A Dental exam and Eye exam may also be required.

School Fees

Bloomington SD13 has a simple fee structure with one annual registration fee applied to each student. Optional fees may also be applicable for non-mandatory items such as daily milk or transportation services.

Payment

Bloomington SD13 uses PushCoin, an online service, for parents to pay for school fees. Email communication from support@pushcoin.com usually begins the first week of March. Visit www.pushcoin.com to add your student to your PushCoin account by clicking the Add User button. Enter the unique PushCoin Registration Code which will be sent from support@pushcoin.com to the email address that you have provided to SD13 when enrolling your student. If you have submitted your enrollment form, and you do not have the unique PushCoin Registration Code by March 15th, please click Request Student Access within your PushCoin account.

Please note:

- the kindergarten / new student enrollment form must be completed and submitted prior to paying your registration fees
- submitted forms must be approved by school staff prior to student records being available within PushCoin
- an early-bird discount is offered for fees paid prior to July 1st
